



## Memorandum of Implementation

## 1. PURPOSE:

This memorandum of implementation (hereinafter called "MoI") has been made and entered into by and between:

#### 3. SEPERATE AGREEMENTS:

Prior to initiating any specific activity or program, the parties will negotiate and enter into a definite agreement, signed by each party's authorized signatory, describing the terms of management, including but not limited to financial commitments, academic freedom commitments, immigration and compliance obligations, and details of the exchange or collaborative relations. This MoI is not intended to create any legally binding obligation on either institution, but it is included to facilitate discussions regarding general areas of cooperation.
